# REPORTS, UPDATES AND INFORMATIONAL ITEMS Superintendent's Report

#### Mr. Craven reported:

- Bill Newkirk and Associates have begun the audit process. A preaudit meeting was held on June 13, 2024 to review the necessary paperwork and documents needed to begin the audit during the week of July 22, 2024.
- The Peru Education Foundation reorganized the executive committee at their June 5, 2024 meeting.
- A preliminary 2024-25 budget will be presented in the regular July board meeting.
- All summer projects are under way and scheduled. Northview parking lots have been seal coated and re-striped. The Parkside gymnasium floor has been repaired and painted.
- Jump Start Summer School will begin on July 22, 2024. We have a total of 81 students signed up with 59 at Northview and 22 at Parkside.
- We will not need to make a working cash transfer to the education fund or transportation fund as initially budgeted. Both funds were balanced budgets without working cash and the district is going another year without using the working cash fund.
- By the request from Member Kampwerth, Superintendent Craven provided the Board of Education with updates referencing the newly adopted, District Strategic Plan.

#### 2024-2025 Combined Parent & Student Handbook Revisions Overview

Mr. Craven provided the Board of Education with the 2024-2025 recommendations and revisions from the handbook committee for the combined parent and student handbook.
